This information pack is an executive summary of a Policy Framework and Strategy that seeks to achieve optimal efficiency and effectiveness in performance and delivery of policing services to the citizens of Kenya. It proposes to reform the command and control structures within the National Police Service and achieve optimal utilization of resources. The reforms are administrative and within the framework of independent command as provided for by the law.

What are the key components of current reforms?	 i) Reorganized National Police Service. ii) Harmonized command structure. iii) New uniforms for General Duty Police. iv) Strengthened Formed Police Units. v) New policy on House Allowance for Officers of all ranks. vi) Integration of Police Officers with communities and neighborhoods.
2.	When is the effective date for these changes?	Immediately after the President issues directive for implementation or as may be communicated.
3.	What are the distinct reporting functions for DIGs and DCI?	 i) DIG-KPS – Public Security and Safety. ii) DIG-APS – Protective and Border Security. iii) DCI – Criminal Investigations.
4.	Is Administration Police Service being disbanded?	No.
5.	Will the constituent services of NPS remain as provided in the Constitution?	Yes.
6.	What will be different?	 i) A larger and more streamlined General Duty Police under KPS. ii) Allocation of distinct functions of Border security, Anti-Stock theft and critical infrastructure protection to APS. iii) Provide House Allowance to all Police Officers regardless of ranks who will live among the communities they serve.
7.	How is reorganization going to affect APS and KPS?	General Duty KPS and APS will integrate to become one under command of DIG-KPS.
8.	Will General Duty APS wear KPS General Duty Uniform?	No.
9.	Will General Duty KPS wear APS General Duty Uniform?	No.
10.	Will the General duty Police change uniform?	Yes.

11.	Will the uniform be different for junior and Senior Officers?	No. All from Police Constable to Inspector General will wear same color and quality.
12.	What will differentiate them?	Only ranks and equivalent decorations.
13.	Which Uniform will the new General Duty Police wear?	GD working dress – Deep Blue. GD ceremonial – Navy Blue. GD working dress Jacket – Deep Blue.
14.	What will happens to same ranks that were formally in KPS and APS?	Ranks will be rationalized and rearranged. Everyone will fit within new hierarchy of command.
15.	Can a former APS become OCS, Sub County, County or Regional Police Commander?	Yes, all the commander positions will be redistributed according to merit.
16.	What will happen to "Askari wa Chief" who was APS?	The OCS will support the chief on need basis. After serving the need, the Police will revert to their post ready for debriefing, review of performance and proceed next assignment.
17.	What will happens to the various APS Posts?	They will be part of the Police Station in the area either as Posts or Patrol Bases.
18.	How will former APS operate in Police Stations?	They operate just like any other KPS General Duty Police. They will process their incidents from arrest to charging and witnessing in courts as well as performing any other Police Station work.
19.	Will the APS or KPS be discriminated by the Commanders?	No. Supervision and discipline will be applied on same standards as per service standing orders.
20.	Will there be abolition of designations in the new reorganization?	Yes.

25.	Will the financial provisions of NPS under NPS Act 2011 part XVI be implemented?	Yes.

28.	What will be the net effect of integration on GDPPR?	General Duty Police Population Ratio (GDPPR) will increase from 1:991 to 1:643 (DCI inclusive).
29.	What is GDPPR?	It is a new measure of citizen's accessibility to policing services. PPR will measure the general ratio for planning and resourcing Police as it includes formed units currently at 1:419.
30.	Will former APS be able to join DCI?	Yes as they will be talent spotted from KPS General Duty.
31.	Are the above changes in line with Constitution?	Yes.
32.	Which section allows the IG NPS to reorganize?	Article 245(2)(b) on independent command and section 10(f-h) of NPS Act 2011 on mandate of IG – NPS.
33.	Is it possible to disband KPS or APS without Constitution amendment?	No.
34.	How will the new APS be organized?	It will be made up of formed units only.
35.	Which are the APS formed units?	 i) Rapid Deployment Unit (RDU). ii) Border Police Unit (BPU). iii) APS Stock Theft Prevention Unit (APS - ASTU). iv) Critical Infrastructure Protection Unit (CIPU).
